The Board is pleased to announce that all the proposed resolutions set out in the notice of AGM were duly passed by the Shareholders by way of poll at the AGM held on 19 November 2020.

The board (the “**Board**”) of directors (the “**Directors**”) of FSE Services Group Limited (the “**Company**”) is pleased to announce that at the annual general meeting of the Company held on 19 November 2020 (the “**AGM**”), a poll was demanded by the Chairman of the AGM for voting on all the proposed resolutions set out in the notice of the AGM dated 19 October 2020 and all resolutions were duly passed by holders of ordinary shareholders of the Company (“**Shareholders**”) by way of poll at the AGM.

There were no shares entitling the holder thereof to attend and abstain from voting in favour of any of the proposed resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”). No Shareholders were required under the Listing Rules to abstain from voting at the AGM. In the Company’s circular dated 19 October 2020, no parties had stated their intention to vote against or to abstain from voting on any of the proposed resolutions at the AGM.
