Election of Language and Means of Receipt of Corporate Communications

The options are:

- Option 1: to receive the printed English version of all future Corporate Communications only; or
- Option 2: to receive the printed Chinese version of all future Corporate Communications only; or
- Option 3: to receive both the printed English and Chinese versions of all future Corporate Communications; or
- Option 4: to access all future Corporate Communications through the website of the Company at www.fseng.com.hk (the “Website Version”) instead of receiving printed copies, and to receive an email notification or a notification letter of the posting of Corporate Communications on the website of the Company.

You are entitled to change the choice of language and/or means of receipt of future Corporate Communications at any time by providing prior written notice of not less than five clear business days to the Hong Kong Registrar by email to fse-ecom@hk.tricorglobal.com or by post to Level 22, Hopewell Centre, 183 Queen’s Road East, Hong Kong. Even if you have elected (or are deemed to have consented) to receive the Website Version of all future Corporate Communications, if for any reason you have difficulty in accessing the Corporate Communications posted on the website of the Company, the Company will, upon receipt of a written request, promptly send you the Corporate Communications in printed form free of charge.

Please note that: (a) printed copies of the English and Chinese versions of all future Corporate Communications will be available from the Company or the Hong Kong Registrar upon request; and (b) the Website Version of both the English and Chinese versions of all future Corporate Communications will also be available on the website of the Company at www.fseng.com.hk and the website of Hong Kong Exchanges and Clearing Limited at www.hkexnews.hk.

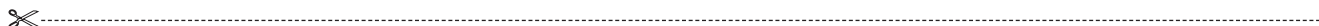
